## **Presentations**

The 8<sup>th</sup> Academic and Health Policy Conference on Correctional Health was held on March 19-20 at the Hyatt Harborside Hotel in Boston. A record two-hundred and sixty participants from 5 countries, 31 states, Puerto Rico and the District of Columbia attended the conference. The conference was founded by department Vice Chair Warren Ferguson and has been supported since its inception by Commonwealth Medicine. Two years ago, the Academic Consortium on Criminal Justice Health was formed to serve as an academic home for criminal justice health scholars, clinicians and policymakers and the Board of Directors, led by Warren, now provides conference oversight. The interdisciplinary design of the conference is its signature, leading generation of new research ideas and collaborations toward improving criminal justice health outcomes.
